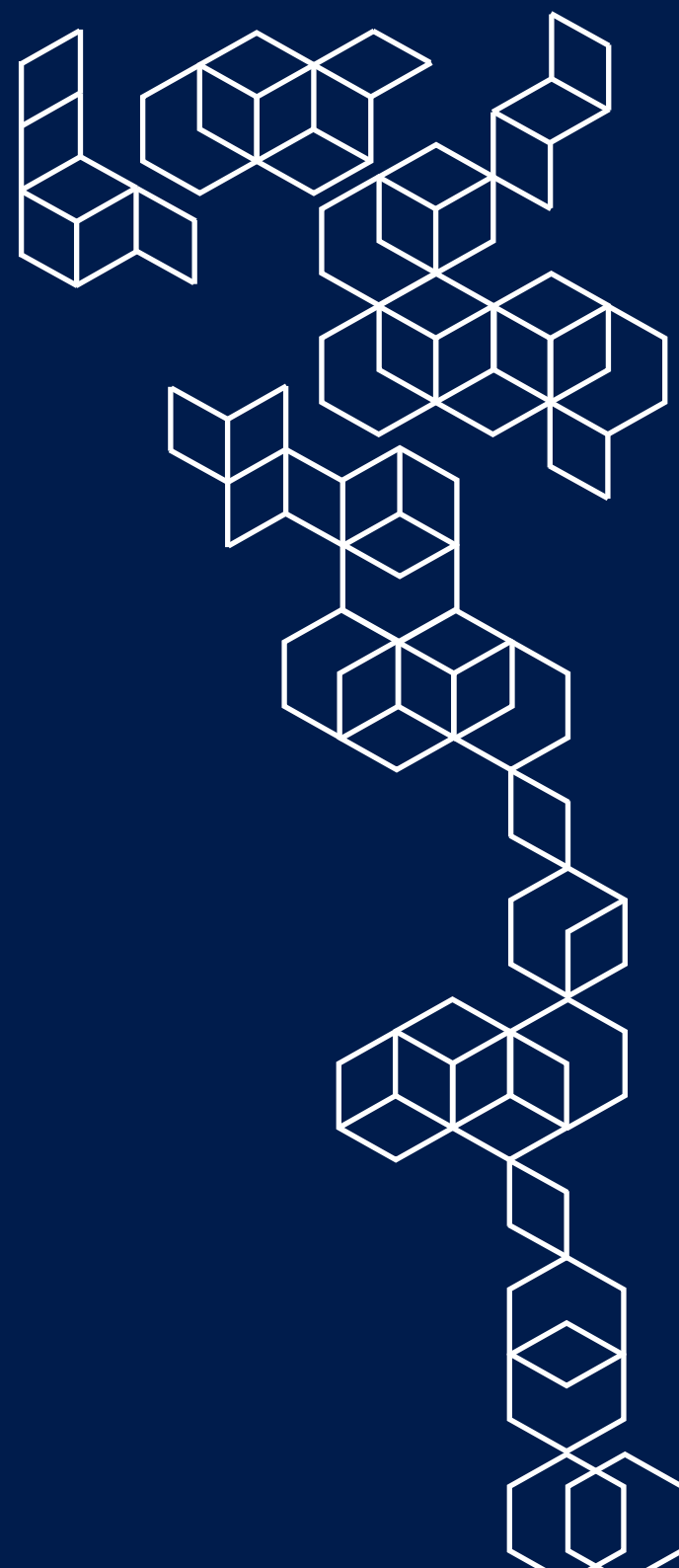

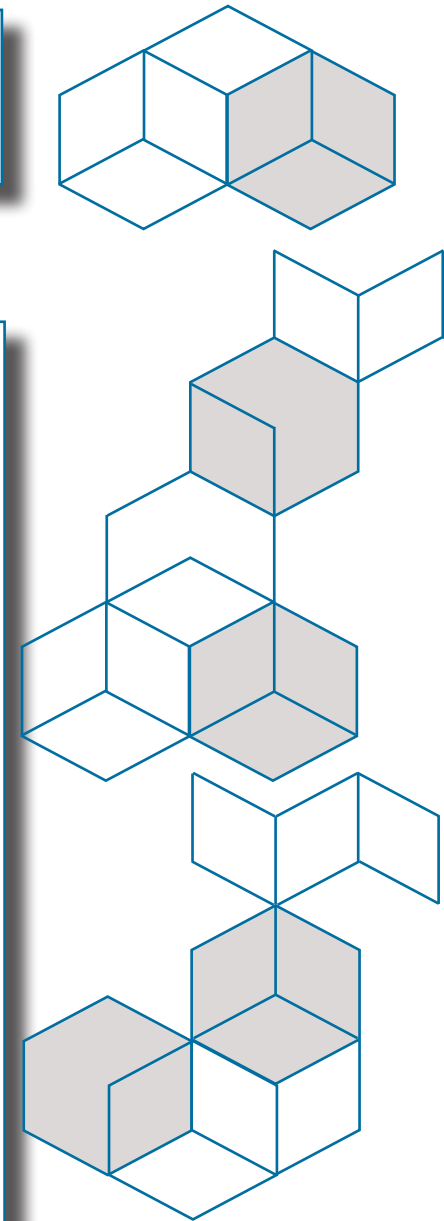
The only business association of the Galician Shipbuilding Sector

Between 2000 and 2006, at the beginning of the Cluster, ACLUNAGA has accomplished a wide range of different projects, regarding areas such as training, Information Technology and prevention of occupational hazards.

Since 2006 ACLUNAGA works in the design and implementation of a new action plan in order to strengthen the Cluster, focused in giving solutions to the main challenges of the Galician shipbuilding sector. 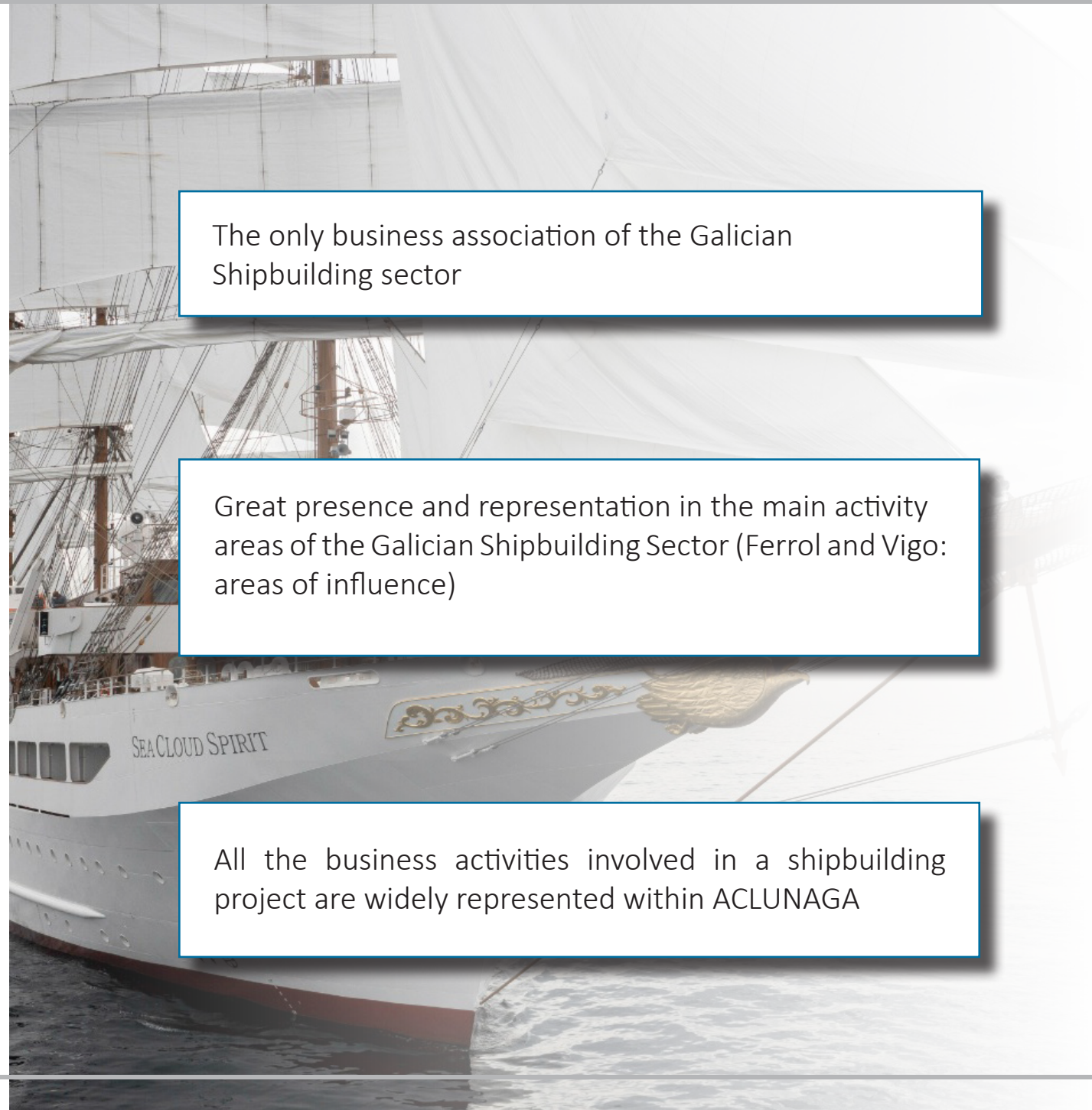

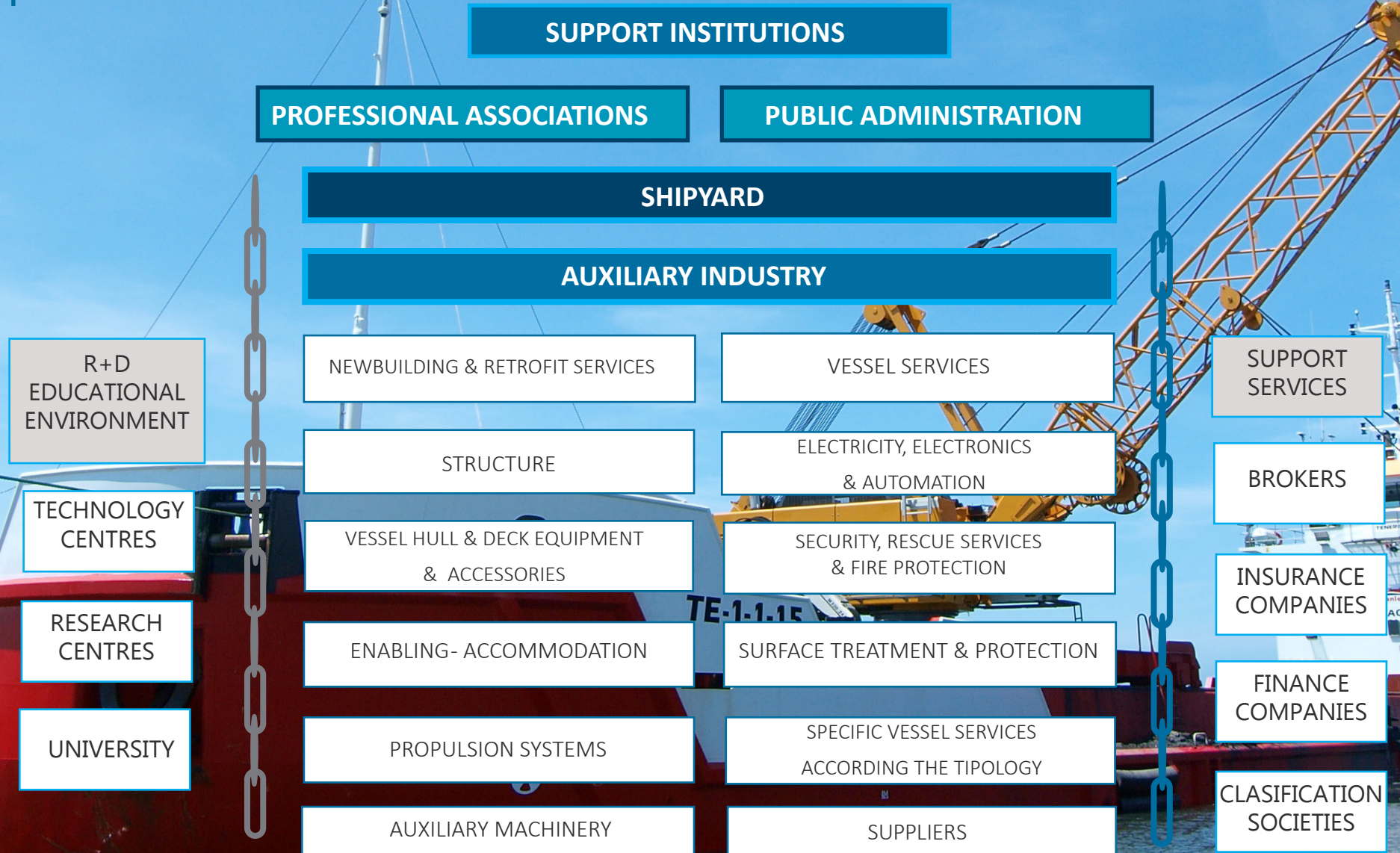

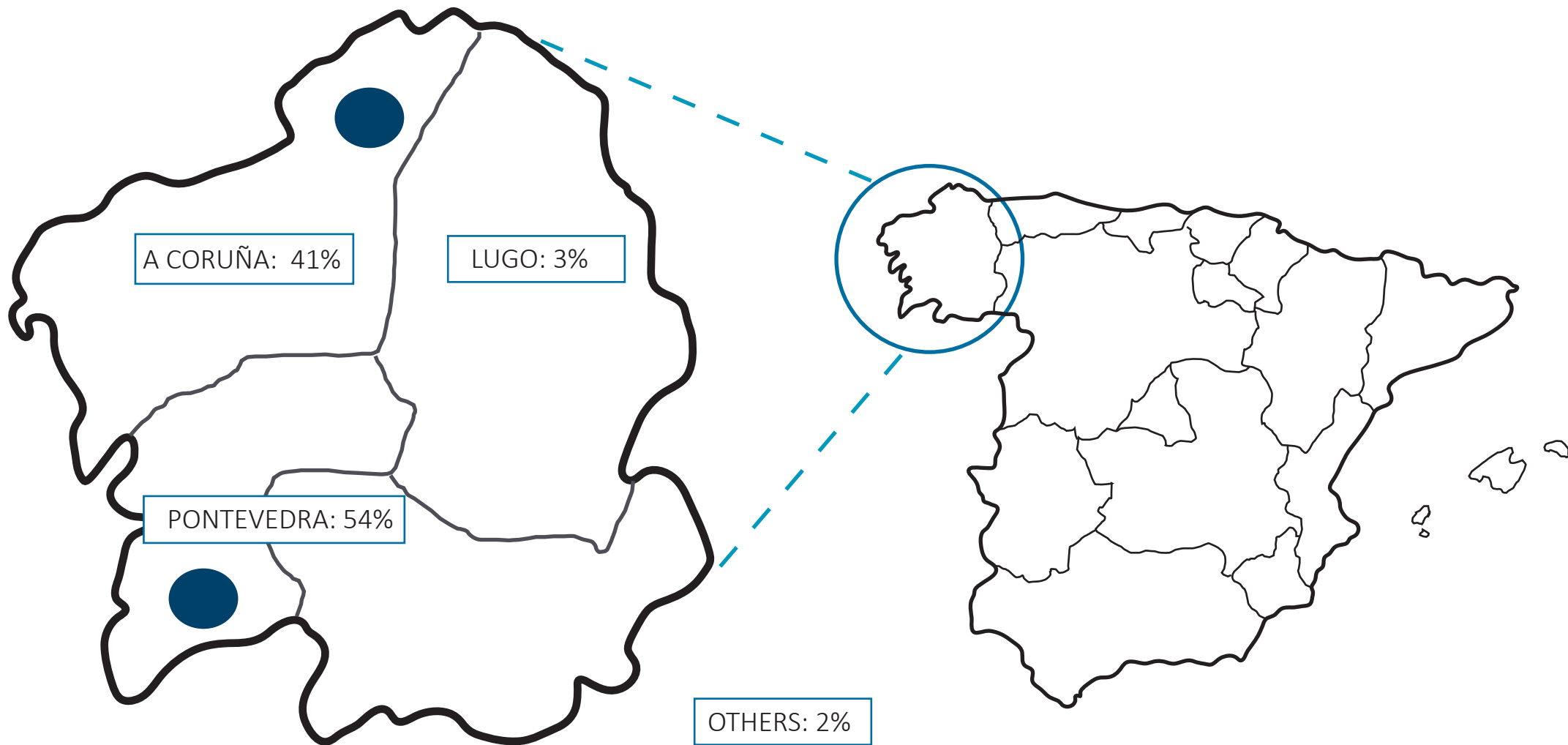
# ACLUNAGA's value chain
